

The West Haven Housing Authority dba Savin Rock Communities will be opening its waiting list for the Housing Choice Voucher Program (HCV), Mainstream Voucher program (disabled persons under 62 transitioning out of institutions, homeless or at risk of homelessness) and Project Based Voucher Program (PBV) (397 Meadowbrook Ct. only) which will subsidize decent, safe and sanitary housing for persons whose income falls at or below the very low-income category as follows, by number of persons in a household.

Pre-applications for the waiting list lottery may be completed and submitted online through a secure site at www.savinrockcommunities.org (click link for application) OR it may be downloaded and printed from www.savinrockcommunities.org or www.cthcvp.org, and completed and mailed to Savin Rock Section 8, P.O. Box 901, Cheshire CT 06410. Only pre-applications submitted online or postmarked November 4, 2019 through November 8, 2019 and received by November 22, 2019 will be accepted. **NO WALK-INS. DO NOT SUBMIT PRE-APPLICATION TO ANY OTHER ADDRESS. IT WILL NOT BE ACCEPTED. DO NOT SUBMIT OR MAIL ANY PRE-APPLICATION BEFORE NOVEMBER 4, 2019 OR AFTER NOVEMBER 8, 2019. IT WILL NOT BE ACCEPTED.** Only one pre-application form per household will be accepted. Only pre-applications that are completed, signed and legible will be accepted. A lottery will be conducted after November 22, 2019 for each program. 1000 pre-applicants will be placed on the waitlist for HCV, 200 for Mainstream and 500 for PBV. **All applicants will be notified by regular mail at the address listed on the pre-application whether selected or not.** Applicants with disabilities or with Limited English Proficiency who require assistance to complete the pre-application may dial 203-934-9266 x100.
