

# MUTUAL RESCISSION OF LEASE AND HAP CONTRACT

3. For Contracts and Leases dated on or before 02/01/96: Upon termination, the owner release their right to any claim or demand of the Housing Authority under Section 1.4 of the HAP Contract, and any claim for Vacancy Loss (No security / vacancy clause in Contracts after 02/01/96).
4. Within the time required by Connecticut State Law, Owner shall refund to the Tenant the Tenant's Security Deposit in the sum of \$ \_\_\_\_\_, together with such statement provided by applicable law.\*
5. If Tenant does not vacate the property in accordance with the terms of this agreement, then this agreement shall be of no force and effect.
